**RULES AND PROCEDURES:**

1. All works must be original and be produced by the artist offering the work for sale. No kits, no commercial molds or green ware, no items representing minor rework, no copy work and no assembly line work. Mechanical reproductions (such as posters) must have prior approval of the jury committee.

2. Artist must be present during the entire show. **ABSOLUTELY NO EARLY BREAKDOWNS!**  
This is a professional show. Artists who breakdown before the show is over will not be invited back.

3. Artist may only display work in the media in which he or she was accepted, and the work shall reflect the quality and integrity of the work juried. Items deemed unacceptable, according to these guidelines, must be removed from the booth. Artists not complying will be asked to leave the show and will not receive a refund.

4. Artists accepted into the show will have their images returned during the set-up if not before. The art offered for sale must be the same type, quality and proportion depicted in the slides submitted with this application.

5. Artists booth display will determine placement in the park. It is important that each display look as professional and inviting as possible so the whole show looks good.

7. Menaul School is not responsible for damage, theft or loss of any exhibitor's work or display during or after show hours. There will be MINIMUM security for booths left set up overnight on Saturday.

8. This is an outdoor event, so be prepared for bad weather, especially rain. However, we will have an indoor space available. Booth fees are not refundable due to bad weather.

9. Lets take care of the grass! Artists must use weights on tents, NO STAKES.

10. Artists are responsible for properly disposing of all trash. Let's leave the park as clean or cleaner than we found it!

11. Artists wanting to share a booth must apply separately and each be accepted by the jury (Maximum two artists). The total cost for one shared booth space is \$175.
